AMENDMENT TO DECLARATION OF CONDOMINIUM
OF THE WHALER CONDOMINIUM

THIS AMENDMENT, made this May 14, 1985, is to amend those certain documents known as the Declaration of Condominium of The Whaler Condominium, a condominium, dated October 9, 1984 and recorded January 16, 1985, in Miscellaneous Book 52, page 592 through 616 of the records in the office of the Judge of Probate of Baldwin County, Alabama, as amended by instrument (to add the exhibits thereto) dated March 29, 1985 and recorded April 3, 1985 in Miscellaneous Book 53, page 972, WITNESSETH:

WHEREAS, The Whaler, Inc., an Alabama corporation, developer of The Whaler Condominium in Baldwin County, Alabama, is desirous of making and recording this special amendment to the Declaration of Condominium pursuant to the authority reserved under the provisions of Paragraph 33 of the same, in order to amend Paragraph 4 and Paragraph 24 of the said Declaration of Condominium.

NOW, THEREFORE, the Declaration of Condominium is amended as follows:

Paragraph 4 is amended as follows:

4. Name and Address of Person to Receive Service. The name and address of the person to receive service of process for the condominium shall be Ronald L. Owen, P.O. Box 1754, Gulf Shores, Alabama 36542.

Paragraph 24 is amended as follows:

24. Leases. No owner may lease less than his entire unit. Any lease agreement shall be required to provide that the terms of the lease shall be subject in all respects to the provisions of the declaration and the bylaws and that any failure by the lessee to comply with the terms of such documents shall be a default under the same.
